1. The undersigned hereby indemnifies and holds Kishugu Aviation (Pty) Ltd, Working on Fire (Pty) Ltd, and their subsidiaries harmless against any and all claims, demands, fines, penalties, actions, proceedings, judgments, damages, losses, costs, expenses, or other liabilities arising from the undersigned's failure to observe or comply with obligations under this agreement, whether caused negligently or otherwise.
2. The undersigned confirms that all suppression operations will be conducted in the presence of the landowner, lessee, or their nominated representative.
3. If Provincial Disaster Management (PDMC) funds the initial hour of operations as requested and approved, the requester shall be fully responsible for all costs incurred thereafter.
4. If aerial support is required beyond the PDMC-funded one hour, the requester must either guarantee payment or provide a deposit to Kishugu Aviation (Pty) Ltd. Operations will continue until the deposit is depleted or increased. Banking details are provided below.
5. **Where the requester is a Fire Protection Association (FPA), the FPA must secure a written guarantee from a third party (such as a landowner, municipality, or sponsor) who will assume full financial responsibility for all costs incurred. Kishugu Aviation reserves the right to decline assistance if such guarantee is not provided.**
6. Invoices must be settled within 30 days of delivery. Late payments will incur interest at 2% per month.
7. **The Signatory hereby irrevocably and unconditionally binds themselves as personal surety and co-principal debtor in solidum for the due and punctual performance of all obligations of the Principal Debtor under this Agreement, waiving the benefits of excussion and division.**
8. **The requester must specify a maximum budget for aerial assistance prior to deployment. Kishugu Aviation will not exceed this budget without obtaining written approval from the requester or their authorised representative. If the allocated budget is reached during operations, Kishugu Aviation reserves the right to suspend services until additional funds or guarantees are provided.**
